MVPC was presented a Commonwealth "Leading by Example Award" for the Plan last October at a ceremony at the State House. Additionally, the Plan received a NADO "Inovation Award" on 8/27/2013. Implementation of the Plan is in process.

Non emergency phone service is a growing trend nationwide, but just catching on in Massachusetts.

Regional Energy Manager	Regional Services	Several communities have been working together through the Merrimack Valley Regional Energy Management program established by MVPC with 2009 DLTA funds. Ameresco has been hired as the preferred vendor to provide regional ESCO services. Ameresco has met and provided some level of technical assistance with all 15 communities and, to date, six have signed investment grade audit agreements. IGA's are now underway and will continue throughout 2013. \$13 million in improvements are expected to be performed.
Region Wide	Brownfields to Solar Farms and Net Metering	Regional Services	MVPC is providing technical assistance to help several communities consider retrofitting closed landfills into "brightfields." Over 100 acres of brownfields/landfills could be used in this fashion. Meridian Associates completed a "fatal flaw" analysis on eleven sites in nine communities. Their findings became an "action plan" which MVPC is helping the towns to implement. A "Regional Energy Manager", Meister Consultants Group, is currently analyzing sites in N.Andover, Amesbury, and Boxford. Meister has also put together a net metering RFP with six of the regions communites. The RFP was issued in February and proposals received March 8, 2013. A Power Purchase agreement between the participating municiplities and American Capital Energy has been developed but awaits SREC II later this year.

Also, MVPC managed the joint regional purchase of a retroreflectometer to assist in inventory of sign assets in respective communities in order to meet new sign reflectivity requirements from FHWA. This effort resulted in saving each community several thousand dollars if they were to purchase their own.
Region Wide	Electrical Energy Purchasing	Regional Services	The Mayors/Town Managers Coalition met with Glacial Energy regarding the possibility of aggregate electrical energy purchasing. The coalition requested MVPC explore this idea in greater detail to determine cost savings benefits to the regions cities and towns and to develop an RFP if feasible. An RFP was issued and bids were received in June 17, 2013. The bids have been reviwed over the summer and the coalition will meet in September to select a vendor.
Haverhill	Reverse Auction	Regional Services	Through MVPC's Mayor's/Manager's Coalition, a list of proposed changes to state law to improve municipal management, was packaged into a "Municipal Relief Proposal". One suggestion was to allow for "reverse auctions", and this idea was approved by the State Legislature. A Boston Globe article highlights how this one tool saved Haverhill thousands of dollars. MVPC is working to use this tool in other communities in the region.
Region Wide	Best Practices Guide	Regional Services	DLTA funds have been used to inventory, categorize, describe, and disseminate relevant and useful information about regionalization best practices. MVPC completed their work with a website designer and the "best practices" website is up and running. Work has been underway towards the development of a "regional healthcare provider
Region Wide	Health Care	Regional Services	network" using a consortium of local hospitals in the MVPC region. The intent is to encourage municipal employees to use the health services of regional hospitals (which are the largest employers in their host communities) through the use of discounted fees for service thus saving cities and towns health care benefit costs. This can be an alternative to communities unable to join GIC. This activity has been very slow to take hold, but discussions continue among the Mayors/Managers and local hospitals and we hope for action in early 2014.
Region Wide	Inspectional Services	Regional Services	Bids to procure the services of certified inspectors (bld., plumbing, gas, health, etc.) to help member communities achieve cost savings by utilizing an "inspectional pool" as needed was opened last spring. Pool to be used to fill various levels of need from backfilling vacation and sick leave to augmenting existing staff to meet uneven demand for inspections. Four health inspectors and three electrical inspectors are available for member cities and towns. This service is now up and running and being used by a few municipalities. MVPC is working to increase the effectiveness of the program by trying to add building inspectors to the pool.
Region Wide	Facilitation	Regional Services	MVPC convenes meetings with the region's decision makers on a regular basis and facilitates strategy sessions where regional solutions to municipal management problems are discussed in hopes of turning these ideas into "actions". Meeting are held monthly with the region's Mayor's and City/Town Managers; monthly with the region's DPW/Public Work's Directors; quarterly with the region's Planning/Economic Development Directors; quarterly with Town Administrators and Finance Directors; and an annual meeting is held with the state senators and state representatives from the region. Many timely topics are discussed such as recent presentations in August and September, 2013 on medical marijuna laws and stormwater regulations.

It also received a 2011- Innovation Award from NADO. Many communities have requested MVPC assist them with plan implementation to include technical assistance to properly develop their "growth districts", as well as assisting them in the preservation and protection of open space. That work is underway and will continue through 2013 and beyond.
